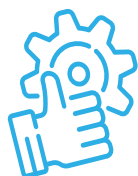

3 ORGANISATION OF MAINTENANCE	50

For children, the pleasure of playing is all the greater if the equipment that is provided for their use is in good condition and checked regularly. This means that they can make the most of the facilities.

The durability and safety of a playground depend to a great extent on the servicing and maintenance work carried out, together with the fact, of course, that the products have been designed in accordance with quality principles, as is the case with PROLUDIC products.

SAFETY STANDARDS

Since publication of the European safety standards in 1998 and their subsequent revisions in 2008 and 2017, the obligations to be met by the operating entity and the equipment supplier have been clearly defined in the form of the normative texts EN 1176-1 and EN 1176-7.

The latter determines various checks to be made at specific intervals.

These intervals are given for information purposes only; they must be adapted to suit the frequency of use and the site.

MONTHLY

- Routine visual inspection to identify the risks stemming from acts of vandalism, use or specific weather conditions.
- Ensure all fixings are securely fastened.
- Check for missing or broken parts.
- Ensure that protective covers are in place.
- Check the equipment weight load for loose-fill surfacing.

EVERY 3 MONTHS

- Functional check to make sure that the equipment, or the part concerned, is operating correctly.
- Check all fixings.
- Check the stability of the equipment.
- Inspect wear levels (flooring, bars, chains, cables, etc.).

YEARLY

- Inspect the anchoring systems.
- Clean thoroughly.
- Check the condition of the supporting structure.
- Check the condition of the lacquered plates.

Once these checks have been made, corrective actions must be taken if the results found so require.

The PROLUDIC Maintenance manual is a practical working document that draws on 30 years of experience ; it is made available to our clients and more specifically those responsible for maintenance work on playground equipment for collective use.

For each type of product, we have compiled a list of the inspection to be carried out together with their frequency.

ASSEMBLY INSTRUCTIONS

The first step to be taken is to ensure that the equipment item lasts a long time and can be used by children safely is to make sure that the installation complies with the information supplied in the assembly instructions.

SOME KEY INFORMATION



Definition of the fixings: each assembly requires a specific combination of fixings to ensure its correct installation.

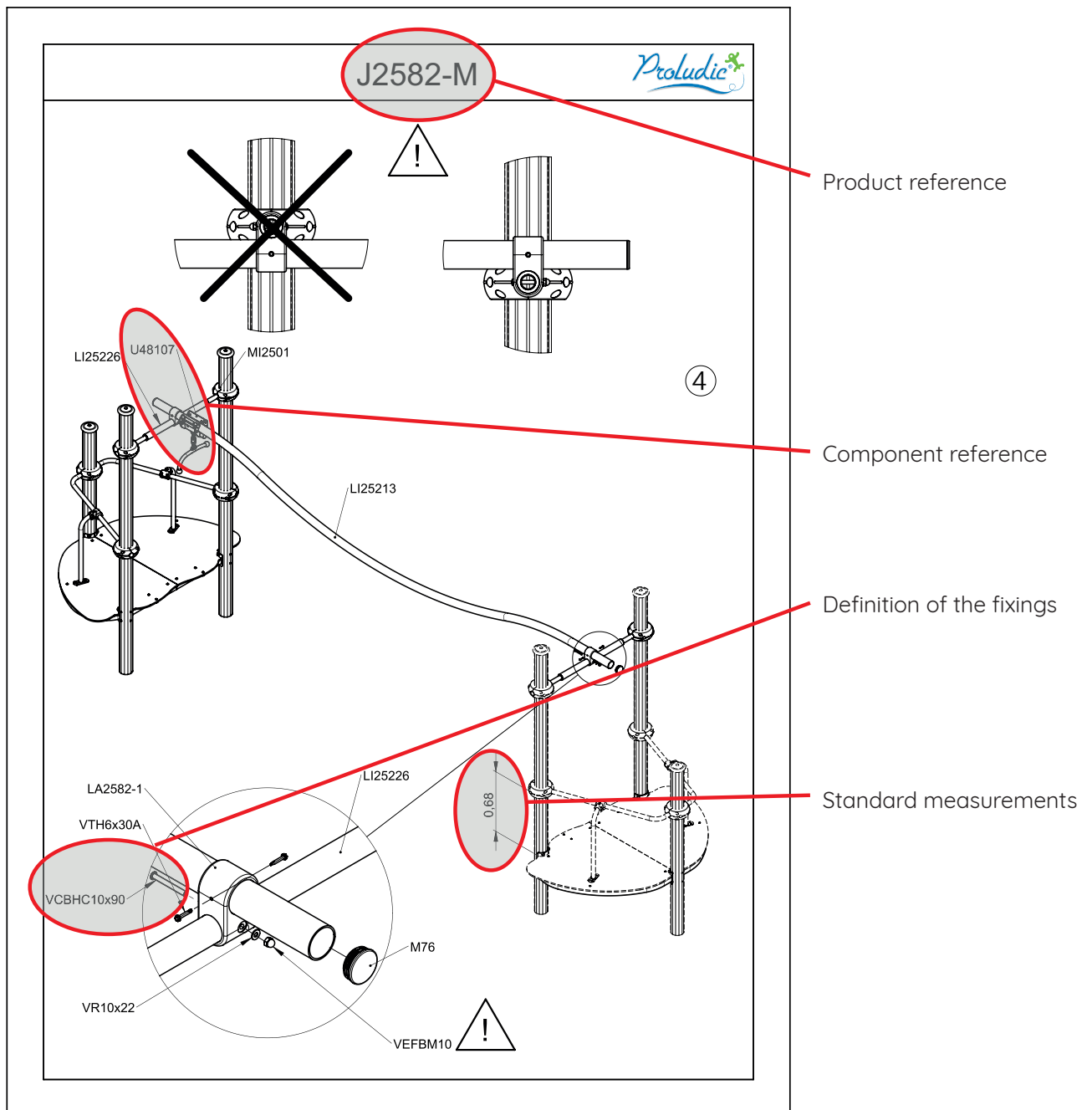

MAINTENANCE OF THE AREA AND ITS ENVIRONMENT

A playground is not limited to the items of equipment making it up; it also includes the safety surfacing and its surroundings that must also be maintained to ensure safe use over a long period.

SAFETY SURFACING

There are various types of flooring, including but not limited to synthetic surfaces and loose-fill surfaces. They have to be maintained in order to conserve their characteristics.

MONTHLY

- Rake to remove all unwanted or potentially dangerous objects (loose-fill surfaces).
- Ensure a consistent level (loose-fill surfaces).

EVERY 3 MONTHS

- High-pressure cleaning of rubber floors.

YEARLY

- Loose-fill surfaces: check the thickness of the layer of loose-fill materials and add extra material as necessary.

SURROUNDING OPEN SPACES

- Make sure at regular intervals that the state of the vegetation present in or around the playground does not present a risk to users.
- Cut the vegetation back if necessary to ensure that it does not reach the impact zones of the playground equipment, which must remain free of all obstacles.
- Check the signs in the playground (updating the telephone numbers and addresses of the organizations to be contacted in the event of an accident, if required).

EQUIPMENT MAINTENANCE

Each playground has a specific maintenance requirement, according to the elements installed and the materials used.

WOODEN POSTS

MONTHLY

- Ensure that there are no splinters present on wooden posts.



YEARLY

- Check that the wood has not split open and that no layers have come unstuck.
- Check that the posts are in good condition.

COLOURED PANELS

YEARLY

- Check the overall condition of the lacquered plates. Check for chipped paintwork on the parts most exposed to friction.
- It is essential to touch up paintwork if the colour has been removed (Plywood).
- Clean with water and detergent using a high-pressure cleaner.

NETS

MONTHLY

- Make sure that the linking elements are in place.

YEARLY

- Check the fixings.
- Check the cable for wear. Replace the cable if the metal core is visible.

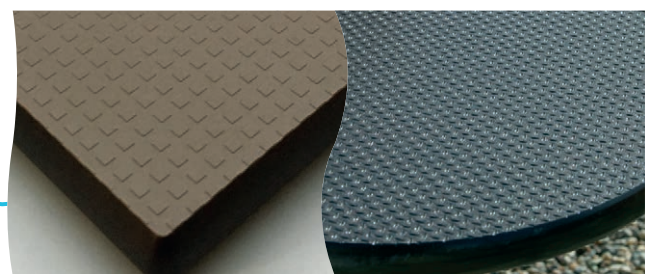

- Check that the cable is not damaged. Check that none of the wires are cut or have become untwisted.
- Verify the integrity of the LI507 cable attachment fittings.
- Check for wear on the seat chain (if it is worn by more than 1/3 of the wire diameter, replace the chain).



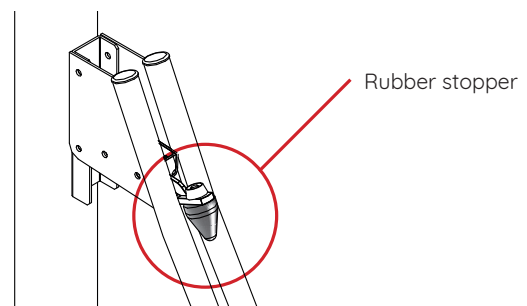
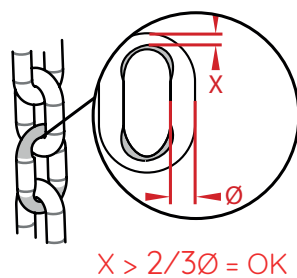

- Ensure the absence of corrosion on the metallic elements.
- Check wear of the jumping surface. Replace if the metal core is visible.

- Check that all the springs are in place and that they are correctly attached to both the jumping surface and the surrounding frame.
- Check that the surrounding safety tiles are complete and firmly in place.

- Assembly instructions.
- Certificates of conformity to standards.
- Maintenance schedule issued by the manufacturer.
- Maintenance schedule for each item of equipment.
- Records of the various interventions.
- Accident declaration form.
- Certificate of conformity to installation standards.



Rigorous organisation is essential for efficient maintenance. It ensures optimum durability of playgrounds and their equipment and enables the products to remain in compliance with the standards applicable.
